Visits were paid to the University and the School of Mines on Monday by Mr. H. J. Bhabha, formerly Inspector-General of Education in Mysore, India. At the University he was received by the Chancellor (Sir George Murray), the Vice-Chancellor (Professor Mitchell), and members of the professorial staff. At the School of Mines he was met by the President of the Council (Sir Langdon Bonython), the Vice-Chancellor of the University, Professor Chapman, and the Principal of the School (Mr. F. W. Reid). Some years ago Mr. Bhabha toured Europe and America to enquire into systems of technical education, and subsequently published, for the Mysore State, a report on manual instruction in schools of general education, which has had a wide circulation. He is accompanying Sir D. J. Tata, Bombay, on a visit to Australia. The latter gentleman is a member of the Board of Governors of the Indian Institute of Science, Bangalore, Southern India, which was founded by his father. DOCTOR OF LAWS.

MR. T. HEWITSON HONORED.

In recognition of his thesis on "The Origin and History of Suretyship," Mr. T. Hewitson, LL.B., S.M., has received notification that the degree of Doctor of Laws will be conferred upon him by the University of Adelaide to-morrow.

The thesis is really an essay in the field of jurisprudence and the subject of suretyship is treated on new lines; in that respect the study is original. It is not a text-book on the rules of law governing suretyship, but a study of the conditions under which it might theoretically be supposed to have originated, and also a study of the comparative conditions under which it has developed under the various systems of law, both ancient and modern.

In the mediæval and modern history of the subject, for example, Dr. Hewitson compared the development in the various European codes and in the English, Irish, and Welsh law, and also glanced at the modern eastern codes.

The treatise was opened with a statement of the provisions of the Code of Hammurabi, and it set out that although there was evidence of the existence of suretyship in Babylonian and Assyrian law long before that time, the code referred to recognised and regulated the pledge and forms of suretyship. Through Abraham suretyship probably became familiar

with the Jews, and mention of it was found throughout the Bible, particularly in Proverbs. From there Dr. Hewitson traced its history through the Greek, Roman, and early Germanic laws down to practically the beginning of English legal history, dating back to the Anglo-Saxon and Anglo-Norman periods. Then he discussed its development and forms in modern law, and pointed out that as a matter of juristic origin suretyship began with Rostage (the pledge of the person) and ultimately developed into the modern contract and judicial forms of suretyship, including bail.

Dr. Hewitson is a member of the Central District Licensing Court, magistrate of the Children's Court, and assistant-magistrate at the Adelaide Local and Police Courts, and is also deputy-coroner. He was born in Cumberland (England) in 1854, and landed in Victoria with his parents in 1859. He was educated at the Windsor Academy and at the Sandhurst High School (Bendigo). After matriculating at the Melbourne University he joined the South Australian Education Department. He became headmaster of the Mount Barker school, and then first assistant at Norwood. After three years' service he resigned, in order to study law. He was an articled clerk with Messrs. Kingston & Kingston, and completed his articles with the late Mr. W. V. Smith. In 1884 he graduated at the Adelaide University, where he was the first Stow prizeman and the first bachelor of laws. For ten years he was assistant law lecturer at the University of Adelaide, but in 1898 he took up the practice of his profession at Port Augusta, where he remained until 1916. Dr. Hewitson was mayor of the town for ten years. In 1916 he came to live in Adelaide, where he started practice, and his partner (Mr. Hubert Nesbit) remained in practice at Port Augusta. In March, 1918, he relinquished his private practice to accept the appointment of a special and stipendiary magistrate in the South-East, in succession to Mr. D. C. Scott, S.M., who was transferred to Port Pirie. After remaining in the South-East until about two years ago, Dr. Hewitson was transferred to Adelaide. He resides at Williams-avenue, Rose Park, and finds recreation in gardening and reading. In 1881 he married Miss Seamonde, of Meadows. The Rev. F. B. Hewitson (of St. Mary's, Burra) is the only son of Dr. and Mrs. Hewitson. Their only daughter (Mrs. E. Davis, who was secretary of the Adelaide Shakespeare Society and the Adelaide Poetry Society) died 12 months ago.

Mr. P. W. Rooney, on whom the degree of bachelor of laws will be conferred today, has had a very successful academic career. He received his early education at Marist Brothers' School, Port Adelaide, where in 1911 he passed the primary and won a two years' scholarship at Sacred Heart College. Here he passed the junior public and the senior public, and won a two years' scholarship at Muirden College. In 1914 he passed the junior commercial in B subjects with five credits, occupied first place, and won the University prize. During 1915 he came first in both the railways clerical and the Commonwealth clerical examinations. He passed the senior commercial in ten subjects with two credits, occupied first position, and won a John Crosswell scholarship. He passed the intermediate accountancy examination of the South Australian Society of Accountants. During 1916 he passed the intermediate law and final accountancy examination of the society, and completed first year of commerce course at University. In May, 1917, he occupied first place in the final law examination in the Society of Accountants, and thus became a qualified accountant on his 19th birthday. In November he completed four subjects in the A.C.U.A. course with two first positions. In March, 1918, he passed senior Latin, and matriculated for the law course. In November he passed the final year A.C.U.A. course, thus completing in three years at the age of 20, and was awarded the Joseph Fisher medal for the most distinguished graduate. At the same time he passed one law subject. During the past four years Mr. Rooney has continued his LL.B. course, and he occupied first position in one subject in this year's examinations. He is an associate of the Commonwealth Institute of Accountants, and of the Australasian Institute of Secretaries. He was appointed to the Federal Taxation Department in 1916, and occupied various positions of importance. Owing to the necessity of attending lectures in the day time his law course has been completed against a series of obstacles. Mr. Rooney, who is 24 years of age, resigned from the service at the beginning of this year, and is practising as a public accountant.

To-day is graduates' day at the University of Adelaide. The annual commemoration ceremony will take place in the Elder Hall this afternoon, and will be presided over by the chancellor (Sir George Murray). A large number of graduates will receive their degrees. The occasion, which is always an outstanding one in Adelaide, will in this instance, be a notable one, inasmuch as the new Governor (Sir Tom Bridges) will be present. Also seated on the platform will be the Vice-Chancellor, the warden of the senate, members of the council, professors and lecturers, members of boards and of the senate, the Registrar, and candidates for degrees and diplomas. The members of the senate and council will wear the academic costume proper to their respective degrees and offices. The "Song of Australia" will be played on the organ as the procession wends its way from the concert room to the Elder Hall. The public, who will be admitted by ticket, will be required to be in their seats not later than 2.45 p.m. A complete list of those who will receive their degrees, was published in The Register on Tuesday.
